Re NY airtel dated 9/17/64, and NY airtel to Bureau dated 5/25/64 entitled "RICHARD CYRIL FRANK, IS-CH" (Bufile 100-401762).

Enclosed are the original and five copies of an LHM dated and captioned as above.

The informant mentioned in enclosed LHM is NY [3809]-S. (S)

The Bureau is requested to inform the Legat, Paris to disregard the lead at Lisbon set out for him in NY airtel dated 9/17/64. The Bureau is requested, through the Legat, Rome, to determine the subject's activities in Milan, Italy and, in particular, to determine if transportation is available from Milan to Albania. (u)

It is pointed out that the subject may have attended a meeting of pro-Chinese militants which was being held in Albania at that time. (u)

It is to be noted that the subject's means of leaving the United States parallels the means used by RICHARD C. FRANK, as pointed out in re NY airtel dated 5/25/64. Both personally purchased their one-way tickets for cash at the main office at Alitalia in NYC. Both were destined for Milan, Italy. This would indicate that neither subject nor her husband wanted their trips to become known.
