Source further advised there is no indication either of them is in other than good health.

Review of the file regarding subject disclosed his subversive activities and potential dangerousness remain the same and there is no information which would change his security index classification.

Inasmuch as SUSAN FRANK, wife of subject, is subject of pending NYO case and information developed concerning subject generally arises as a result of investigation of the activities of his wife, NYO is placing case in a closed status to avoid duplication.

Information concerning subject will be channeled to subject's case file and all significant data pertaining to subject will be furnished the Bureau.
