On 4/10/72, CSLA 4143-S advised SA BURL P. MIDDENDORF that telephone number (213) 459-1493 is subscribed to by BERNARD TRIBNER, 16601 Marquez Avenue, Pacific Palisades, California. This is a published number according to this source. (Pacific Palisades is a suburb of Los Angeles.)

On 5/8/72, CSLA 4178-S advised that telephone number (213) 276-5325 is a published number subscribed to by L. GOULD, 1459 South Wooster, Los Angeles, California (on the border between Los Angeles and Beverly Hills).

On 5/8/72, CSLA 4178-S further advised that telephone number (213) 933-6789 is a nonpublished number, "disconnected" 11/27/71, subscribed to at that time by CHARLES GOULD, 1927 South Orange Drive, Los Angeles, California (this is on the border between Los Angeles and Santa Monica).

When sufficient background information has been obtained, Los Angeles will review office indices and report pertinent information, if any.
