Miss MIRTA BORRAS ALMANZA, PSI-Under Development, who has furnished reliable information in the past, on 6/22/65, stated that the JURE would hold a convention in Tampa, Florida, over the weekend of 7/3/65. She said she did not intend to go to this convention, but there would be delegates from various cities where the JURE has representatives.

Miss BORRAS advised that she did not see anything of value which might come out of this convention as the JURE was in a very difficult financial situation and among the Cuban exiles there is an overall spirit of depression and frustration.

Miss BORRAS stated that she would inform the NYO of any information she received concerning this convention.
