ANTI-FIDEL CASTRO ACTIVITIES. IS DASH CUBA. REURTEL OCT. TWENTYFOUR LAST CONCERNING DEPARTMENT REQUEST FOR IDENTITY, AVAILABILITY AND WILLINGNESS TO TESTIFY OF ALCIDES DE LOS REYES. DE LOS REYES BORN IN CUBA AND BECAME U. S. CITIZEN BY NATURALIZATION NINETEEN FORTY. IS LICENSED TO PRACTICE MEDICINE STATE OF CALIF. IS VETERAN USAF, WORLD WAR II. PERMANENT RESIDENCE LOS ANGELES, CALIF. WAS IN CUBA DEC. FIFTYEIGHT TO JUNE TWENTY, FIFTYNINE. AFTER CASTRO GOV-T TOOK OVER WAS TWICE IMPRISONED AND ACCUSED BY CASTRO GOV-T BEING COUNTER-REVOLUTIONARY. HAS BEEN MIAMI SINCE FIFTYNINE AND HAS WIDE ACQUAINTANCE AMONG ANTI-CASTRO LEADERS, MIAMI.
