Regarding the instructions and provisions set out
in the above referenced letter, the following information is
set forth:

Regarding the possibility of (VIKTOR LESIOVSKI) having
been in New Mexico in the last two years, reference is made to
Albuquerque teletype 4/19/69 and airtel of 5/8/69, with infor-
mation confirming his presence in Santa Fe on 4/18/69. At
that time, he had travelled alone and dined at the home of
SAMUEL BALLEEN of Santa Fe who is the President of the Cor-
poration that owns the La Fonda Hotel at which he stayed.
It is possible that the above captioned subjects may also
have been present at BALLEEN's home that particular evening.

As a matter of interest, it is noted that (LESIOVSKI)
had returned from (the Soviet Union) on 6/26/69. The phone
calls to the above subject in question were made on 7/11
and 12/69. The original phone records furnished by
NY (7400-S) were again reviewed and the additional pertinent
information was obtained. As previously noted, all of these
calls in question were made from Martha's Vineyard, Massachu-
setts. The bill reflects that the call made on 7/11/69
(Friday-to HILL) was a direct dial call and lasted for
approximately two minutes.

The call made on 7/12/69 (Saturday-to NOSS) was a collect call and consequently not direct dial and was approximately seven minutes in length. U

It is noted that another phone call was also made on 7/12/70 to Greenwich, Connecticut. Investigation has established that this call was made to a phone subscribed to by JOSEPH HYMAN FILNAR (Bufile 100-2341) and to DORIS JONES FILNAR (Bufile 100-410630). The FILNARS are former subjects of the NYO with long time CP affiliations. As a matter of interest, all the phone numbers furnished by NY [7400] S (S) and set forth in NY let of 6/4/70, have all been subsequently shown to unquestionably have been made by the subject. X

X NY [7400] S (S) was contacted on 10/13/70, relative to the above matters and was unable to furnish any observations of value other than the fact that [LESIOVSKI] is seemingly personally acquainted with every section of the US through travel. The NYO has no observations on the significance of the age difference of the subjects or the sequence of the calls. X [X] [U]

It is noted that HILL is formerly from Houston, Texas, and in any anticipated contact with him, this background might be utilized as an entrep pretext. The pretext entrep of NOSS is considerably easier because of his background of employment by the University of California. It is felt that this facet of NOSS' background should be further explored. Both pretexts could be of the nature of a survey of leading members of the community to determine if they have been experiencing any contacts with persons [X] [U] representing business or cultural interests of the Soviet [X] [U] Union or Satellite countries. The NYO does not feel that [X] [U] interviews of the subjects will endanger the security of NY [7400] S (S) because of the unusual nature of the original information and how it was furnished and subsequently determined. X
