If the files of your office contain no information which would preclude contacting these 3 former informants, they should be contacted and you should determine their availability and willingness to testify at an administrative hearing in the Passport Office regarding the possible Communist Party membership of subject. This information should be promptly forwarded to the Bureau. You should include any comments which you consider pertinent regarding the
