On 10/28/68, NY 4047-S* advised that LEE (LNU) had been in contact with SUE FRANK in New York City on that date. FRANK indicated a willingness to speak before a group if LEE would advise her in advance of the date and time for the meeting so she could then determine if she could attend.

LEE said there might be a meeting in February, 1969, and FRANK said she might be free to attend, but could not decide until she hears of a definite date. FRANK indicated no concern about the format of the proposed meeting, or whether it would be open to the public, but only wanted to know if and when there would be one.

The above information from NY 4047-S* has been paraphrased to protect this highly sensitive source, and the identity of NY 4047-S* should be concealed by a T symbol if this information is disseminated.
