Re Miami report of SA ROBERT JAMES DWYER, 5/18/62.

NY 3248-S, on 7/10/62, CSNY 2822-S, on 7/11/62,
 CSNY 2623-S, on 7/10/62, and NY 2865-S, on 7/18/62 advised that
 they knew of no activity on the part of the Ejercito Libertador
 de Cuba (ELC) in the New York area, nor did they know of the
 existence of any group of the ELC in New York.

Dr. ERNESTO ARAGON y GODOY, Secretary to Dr. JOSE
 MIRO CARDONA, whose identity should be protected, and who has
 furnished reliable information in the past, advised on 7/18/62
 that he had heard of the formation of another group in which
 Dr. FELIPE PAZOS was involved. ARAGON stated that he had also
 heard that ERNESTO BETANCOURT, of Washington, D. C., was active
 in organizing this ELC in the Washington, D. C. area. ARAGON
 stated that he had no details relative to the activities of
 the ELC and knew of no existent group in the New York area of
 the ELC.

ARAGON stated that several months ago, he had heard
 of the formation of the Liberation Army of Cuba which was alleged
 to have existed inside Cuba, and this group was alleged to have
 been headed by "NINO DIAZ, but he could furnish no information
 or definite facts concerning the actual existence of such an
 army inside Cuba.

The NYO will remain alert for anything indicating
 the formation of a group of the ELC in the New York area. If
 such a group is organized, the Bureau and appropriate offices
 will be so advised.
