Enclosed herewith are 6 copies of a LHM dated and captioned as above containing information furnished by NY 4533-S (Overland) on 1/8/65 and 1/26/65 (S) to SAS W.L. STITELER and EDWARD J. MURPHY. The informant obtained the instructions as set forth in the LHM from his Soviet principal, GENNADI A. KAMENSKIKH, a known KGB (S) employee at meetings with KAMENSKIKH on 1/7/65 and 1/23/65. (S) KAMENSKIKH's identity has not been set forth in the enclosed LHM in order to adequately protect the informant's security. (S) (u)

The LHM is classified "Secret" as information pertaining to the Overland case has been so classified by the Bureau. (S) (u)

In January, 1965, a confidential informant who has furnished reliable information in the past advised that the Soviet Intelligence Service in the United States desired to obtain any information available on the following organizations:

- Alfa 66
- Movimiento Revolucionario Popular
- Movimiento Renasador Revolucionario
- Representacion Cubana En El Exilio

It is noted that Alfa 66 is an anti-Fidel Castro organization more commonly referred to as Alpha 66.

The Movimiento Revolucionario Popular (MRP) could be identical with an anti-Fidel Castro organization called Movimiento Revolucionario del Pueblo (MRP) which has its headquarters in Miami, Florida.

The Movimiento Renasador Revolucionario (MRR) may be identical with Movimiento Recuperacion Revolucionario (MRR) which is an anti-Fidel Castro organization headed by Manuel Artine Buesa, President of MRR.

The Representacion Cubana En El Exilio is an anti-Fidel Castro organization with headquarters in Miami, Florida, headed by Jose "Pepin" Bosch, owner of the Bacardi Rum Company.
