On December 17, 1963, Aldo Vera Serafin, 1382 N. W. 34th Street, Miami, advised he is the head of the American Patriotic Action Movement, an anti-Fidel Castro organization. Vera said he was previously connected with the JGCE, but this organization is no longer in existence because Sierra ran out of money. Vera said the JGCE is now inactive, and Sierra has returned to Chicago, Illinois

FLORIDA

On January 21, 1964, MM T-1, who has been involved in Cuban revolutionary activities for the past four years, advised that the JGCE has had no activity since about November, 1963; the organization no longer exists; and, Sierra has returned to Chicago, Illinois.
