Previous memoranda have indicated that one of our informants had been approached by Orlando Bosch Avila, head of MIRR, militant Miami, Florida, anti-Castro organization, to pilot plane on raid over Cuba. Plan submitted by Miami Office to thwart raid and protect our informant by establishment of appropriate roadblock manned by Customs and others was discussed with Department. Department concurred with plan and emphasized that the primary objective was to stop the raid. Information concerning MIRR plans was furnished White House and Attorney General. (S)(U)

On April 22, 1966, Customs, Miami, advised that Bosch and two others were arrested by Collier County, Florida, Sheriff's Department for being in possession of explosives. Six bombs were confiscated.

ACTION:

If you approve, the attached letters will be sent White House and Attorney General advising of the seizure of the bombs and apprehensions.
