INTERNAL SECURITY - CUBA
NEUTRALITY MATTERS

MM T-1, a former Cuban Government Official, on November 14, 1966, advised that Radio Havana and Station CMQ, Havana, on November 14, 1966, at 6:00 AM, announced the bombing of a Cuban nitroglycerine plant at Matanzas, Cuba. According to the Official Communication of the Ministry of Cuban Revolutionary Air Force, Havana, three bombs were dropped during the early morning hours of November 13, 1966.

The bombs were dropped from an airplane flying very low to evade radar detection and the airplane reportedly came from and returned to the north. One bomb exploded and caused some damage to the "Consolidado Petro Nitro" plant near Matanzas Bay. Two bombs failed to explode.

MM T-1 further advised that at 11:00 AM on November 14, 1966, ORLANDO BOSCH AVILA, head of the Movimiento Insurreccional de Recuperacion Revolucionaria (MIRR), an anti-CASTRO organization, sent a notice to the Spanish language radio stations WHIE and WFAB in Miami. This note claims that the bombs dropped in Cuba on November 13, 1966, were the responsibility of his organization. The note stated a press conference would take place on the afternoon of November 14, 1966, and further details would be given.

On November 15, 1966, ORLANDO BOSCH AVILA advised that he cancelled his press conference scheduled to take
