Continued contact with TP 52-S and other Tampa sources has failed to reflect any organized activity of captioned organization in the Tampa area.

RNMENTONNENTIAL

On 1/28/67, several of the Anti-Castro organizations in the area met at the Caballeros de la Luz Lodge, Nebraska and 9th Avenue, Tampa, to celebrate the anniversary of the birth of JOSE MARTI, Cuban patriot. ENRIQUE SOMEILLAN, Secretary General of MIRR in Tampa, was present at this meeting. The sponsors of this celebration were all revoluntionary groups of Cubans and Tampans opposed to the FIDEL CASTRO Government.

On 3/6/67, TP 52-S advised that ENRIQUE SOMEILLAN continues to represent MIRR in Tampa, Florida. Source advised that as in the past, the Tampa unit is interested mainly in circulating propaganda advocating the overthrow of FIDEL CASTRO and his government and the liberation of Cuba. He also advised that MIRR's fundamental objectives continue to be as follows:

1. Liberation of Cuba

2. Restoration of the Cuban Constitution of 1940.

3. The return of all Cubans to Cuba

On 3/6/67, TP 225-S advised that MIRR is relatively inactive in Tampa at the present time. The only thing known they are doing is raising funds. This they are doing by selling at \$2,00 each, raffle tickets on a home supposedly valued at \$10,000.

Details of the JOSE MARTI anniversary celebration held at Tampa on 1/28/67, were furnished to the Bureau and Miami in LHM captioned, "ANTI-FIDEL CASTRO ACTIVITIES", dated 2/7/67.

No other activity of MIRR has been reported since referenced letter.
