NO 105- The above are allegedly notes of subject furnished by PCI BETTY PARENT. (S)(u)

Two copies each of the above listed are being furnished to the New York Division to facilitate handling of leads set forth herein and one copy of each of the above are being furnished to the Miami Division for information in view of the interest of that office in Cuban matters.

The Bureau's attention is directed to the letterhead memoranda contained in referenced New Orleans airtels, which letterhead memoranda contains information attributable to PCI BETTY PARENT, New Orleans, Louisiana, indicating that subject claims to be working with CIA and contains background information concerning DALZELL. (S)(u)

Referenced Bureau letter advised that DALZELL was not connected with CIA. (S)(u)

The enclosed handwritten notes indicate that subject is in contact with a "Mr. RAYMOND, Pan-American Radio, Inc., 104 Rockefeller Plaza, New York City, New York." (S)(u)

(u) The Laboratory is requested to make an analysis of the handwritten ciphers contained on the aforementioned enclosed notes to determine whether or not the ciphers contain a coded message. (S)(u) The Laboratory is also requested to furnish any pertinent information obtained as a result of its examination, which may be of assistance in future interview of subject. (u)

2-11-3 The New York Division is requested immediately to ascertain the full identity of "Mr. RAYMOND, Pan-American Radio, Inc., 104 Rockefeller Plaza, New York City, New York," and all pertinent background data regarding him. Although CIA has advised that DALZELL was not connected with CIA, it is conceivable, based on information contained in the notes attributable to DALZELL, which are enclosed, that "Mr. RAYMOND" may possibly be a CIA source. (S)(u)

NO 105- It is being left to the discretion of the Bureau as to whether or not any of the enclosed material should be disseminated to CIA under the caption "FRENTE REVOLUCIONARIO DEMOCRATICO." (S)(u)
