[TEPEDINO] said he intended to make a fast trip to Canada to talk to JOSE REBELLON, present head of the Cuban Federation of University Students (FEU), who is at a conference at La Valle, Quebec, Canada, and who is a long time acquaintance of [TEPEDINO]. *(S)(u)*

[TEPEDINO] will advise MM 761-S of the results of any meeting.

Miami will keep Bureau advised of any information received.

Three additional copies are included for Bureau for transmittal to Legats Bern, Paris and Madrid for their information.

Information copies are designated for New York, San Juan, and WFO because of their interest in Cuban matters.
