15. WARNING NOTICE - SENSITIVE INTELLIGENCE, SOURCES AND METHODS INVOLVED. DISSEMINATION AND EXTRACTION OF INFORMATION CONTROLLED BY ORIGINATOR. 89987

(S/NOFORN/WMINTEL/ORCON) ACCORDING TO AMADO PADRON, CONSUL ASSIGNED TO THE CUBAN EMBASSY IN PN, LTC MANUEL A. NORIEGA, NATIONAL GUARD (GN) G-2, RECENTLY (WITHIN THE LAST TWO WEEKS) TRAVELLED TO CU AT THE INVITATION OF CUBAN PREMIER FIDEL CASTRO. THE LENGTH OF NORIEGA'S VISIT, HIS DEPARTURE/RETURN DATES AND MEANS OF TRANSPORTATION ARE UNKNOWN. WHILE HE WAS IN CU, NORIEGA TURNED OVER TO JOSE ABRANTES, CHIEF OF THE CUBAN DEPARTMENT OF STATE SECURITY (DSE), INFORMATION DERIVED FROM THE INTERROGATION OF ORLANDO ROSCH, THE ANTI-CASTRO EXILE LEADER WHO IS CURRENTLY BEING HELD BY VENEZUELAN AUTHORITIES FOR HIS ALLEGED ROLE IN THE 6 OCT 76 BOMBINGS OF A CUBAN AIRLINER NEAR BARRADOS. THE GN G-2 OFFICE OBTAINED THIS INFORMATION FROM VENEZUELAN AUTHORITIES IN LATE OCT 76. REPORTEDLY, NORIEGA AND ABRANTES REACHED AN ACCORD CALLING FOR THE CONTINUATION OF COLLABORATION BETWEEN THE GN G-2 OFFICE AND CUBAN INTELLIGENCE SECURITY SERVICES ON MATTERS PERTAINING TO CUBAN AND PANAMANIAN EXILE ACTIVITIES AND ELEMENTS. AS PART OF THIS ACCORD, THE CUBAN SERVICES ALLEGEDLY WILL ASSIST THE G-2 OFFICE IN ASSASSINATING LUIS CARLOS MULLER, AN ANTI-GOVERNMENT OF PN (GUP) CONSPIRATOR RESTING IN GUATEMALA (GT), AND ROBERT MARTINEZ, A FORMER GN OFFICER WHO IS CURRENTLY A POLITICAL EXILE IN THE MIAMI, FLORIDA, AREA. PADRON, WHO WAS IN CU AT THE TIME OF NORIEGA'S VISIT, INDICATED THAT PREMIER CASTRO MET WITH NORIEGA AND EXPRESSED HIS APPRECIATION AND PRAISE FOR THE ASSISTANCE WHICH THE GN G-2 OFFICE HAS RENDERED HIS GOVERNMENT TO DATE.

THE NO FOREIGN RELEASABILITY CAVEAT IS AFFIXED TO PRECLUDE REVELATION OF U.S. INTELLIGENCE INTEREST, ACTIVITIES, HOLDINGS OR CHARACTERIZATION OF INFORMATION.

A. REFERENCED IR 2 231 0447 76 REVEALED THAT NORIEGA WAS TENTATIVELY SCHEDULED TO DEPART FOR CU ON 30 OCT OR 6 NOV 76.

B. THIS REPORT IS SIGNIFICANT IN THAT IT PROVIDES FURTHER INDICATIONS OF DEVELOPING FORMALIZED COLLABORATION BETWEEN THE GN G-2 OFFICE AND ITS CUBAN COUNTERPARTS.
