Re Norfolk airtel to the Bureau 7/25/60 captioned as above. Further reference is made to Norfolk airtel to the Bureau dated 5/17/60 entitled, "JAMES W. ORE, JR., NM".

Enclosed for the Bureau are nine copies of a letterhead memorandum entitled, "JAMES WILLIAM ORE, JR., NEUTRALITY MATTERS". Two copies of this memorandum are furnished Miami because the Bureau indicated in Bureau airtel dated 5/19/60 (captioned as above) that ORE appeared to be involved in the same activities described by DIAZ LANZ to Miami.

A source in Norfolk, Confidential Informant NF-119-S, has furnished information concerning ORE's activities and this source will be alerted to continue to furnish any information on ORE.
