Enclosed are five copies to the Bureau and one copy to Miami for information of a letterhead memorandum and evaluation memorandum dated and captioned as above.

The information in the enclosed letterhead memorandum was furnished by WF 1161-S to SAs DONALD HOETING (C) and JOSEPH E. SCULLY on 4/20/61. (X)

In addition to the information furnished in the letterhead memorandum, the informant advised that he would take steps to determine the whereabouts of CHIVAS and BARQUIN as soon as they arrive in Washington, D. C., and immediately advise WFO. (X)(U)

The informant determined from ERNESTO BETANCOURT on 4/20/61, that CHIVAS and BARQUIN have indicated that they now want nothing whatsoever to do with any representative of Central Intelligence Agency (CIA), but wish instead to deal with members of the FBI requesting that the FBI act as liaison for them with CIA. (X)(U)
