Enclosed herewith are 9 copies of a letterhead memo to the Bureau and one each for New York and Miami for information along with its associated memo of evaluation.

On 4/7/61, RAMIRO LOYS, WPCS, contacted SA JOHN L. SPURGERS, JR., and furnished the information in enclosed letterhead memo. LOYS stated the reason he was at the National Airport was to meet his wife's annt, ANGELA MALLEZA de MARTIN and her five year old daughter YOLANDA, both of whom arrived on the same plane as MANOLO RAY and wife from Miami, Florida. He stated he knew RAY personally and had obtained this information from him in confidence after seeing him and his wife depart the plane. He stated he engaged RAY in conversation because of their past acquaintances in Cuba and RAY's connection with Anti-Castro activities in the U. S.

The enclosed letterhead memo is classified "Confidential" since information contained therein could result in the identification of an informant of continuing value and compromise his future effectiveness.
