Attached are ten copies of a letterhead memorandum setting forth additional information on this matter, as well as ten copies of an evaluation memorandum. Source T-1 in the letterhead memorandum is ANGEL MIRANDA URRUTIA. He was introduced to the writer by JESUS MANZARBEITIA, treasurer in Spain of the delegation of the Frente Revolucionario Democratico and a good contact of the Madrid Office. MANZARBEITIA said that MIRANDA URRUTIA had worked for him for a number of years in Havana for his business and he vouched for him completely.

The memorandum has been classified confidential to protect MANZARBEITIA and MIRANDA URRUTIA since it is anticipated that the latter will continue to furnish information of Bureau interest to the Madrid Office. A copy of the memorandum was disseminated locally to the CIA here.

An extra copy of this letter is attached for forwarding by the Bureau, together with a copy of the letterhead memorandum to the Miami Office for information in view of the fact that MANOLO RAY, mentioned in the letterhead memorandum, is believed to be in the Miami territory at the present time.

The Madrid Office will continue to follow this matter here and the Bureau will be advised.
