On June 4, 1962 PSI MARIANO ROCA, San Juan, Puerto Rico advised that he had a long personal talk with his close friend, Dr. JOSE MIRO CARDONA, head of the CONSEJO REVOLUCIONARIO (Revolutionary Council) on the weekend of May 26, 1962 at Miami, Florida. (X)(u)

During their talk Dr. MIRO CARDONA spoke of his conference on April 10, 1962 with President KENNEDY. The President's comments to Dr. MIRO CARDONA, the details of which are not known to the aforementioned PSI, apparently centered around the present Cuban situation and the present United States policy in this regard. Dr. MIRO CARDONA stated that the name of MANOLO RAY came up in their conversation and the President referred to RAY as "that liar." (X)(u)

It is noted that MANOLO RAY was the leader of the MOVIMIENTO REVOLUCIONARIO DEL PUEBLO (Revolutionary Movement of the People) (MPR) prior to the invasion of Cuba in April, 1961.

The aforementioned reported remarks of President KENNEDY regarding MANOLO RAY are being furnished the Bureau for its information and this is not being disseminated. (X)(u)
