is associated with some members of the MIRR, reported that BOSCH had recently contacted Dr. ~~DENIO FONSECA~~ and ~~GUILLERMO MORALES~~, leaders of the ~~MOVIMIENTO REVOLUCIONARIO FRANK PAIS~~ (MRFP), an anti-CASTRO group of Cuban exiles in Miami. He appealed to them to support an MIRR plan to picket in Miami as a protest against the arrest and prosecution of JOSE RODRIGUEZ PEREZ. Both FONSECA and MORALES told BOSCH that they could not commit the MRFP because such action might be interpreted as a protest against the United States government, and the MRFP did not want to become involved in such activity. They pointed out to BOSCH that the guilt or innocence of RODRIGUEZ should be determined by the federal court. They also advised BOSCH to forget about the picketing since he is in enough trouble already.

On January 18, 1966, MM T-3, a former Cuban official who resides in Miami, advised that at 8:20 AM that day an announcement was made over Miami radio station WFAB, by the MIRR urging Cubans to picket the United States courthouse in Miami where a hearing was scheduled that day for RODRIGUEZ. It was observed this picketing did occur as planned during the morning and afternoon at the courthouse. About 50 Cubans participated. The federal judge refused to reduce RODRIGUEZ' bond and ordered him returned to Puerto Rico for trial.

On January 13, 1966, MM T-2 advised that BOSCH and MARCELINO GARCIA disclosed that they were going to attempt to form a unity of Cuban exile groups. BOSCH explained that this would make it more difficult for

U.S.A. { who is closely acquainted with some members of the MIRR, advised that ~~ORLANDO REGO~~, auditor, prepared a financial report dated September 25, 1965 on the MIRR. Both REGO and ~~LAREDO RODRIGUEZ~~, treasurer of the MIRR, officially resigned from the MIRR in November, 1965 in protest to questionable procedures of the organization in the reporting of income and expenditures. They also were in disagreement with the leadership of BOSCH and GARCIA and their hostile attitude toward the United States.

The following is a summary dated September 25, 1965 of the auditor's report:
