The info contained therein was furnished to SA RICHARD E. KELLOGG by MI 639-S on 4/14/59. Also enclosed are the same number of evaluation memos.

Informant said DEL PINO talked to DON LUIS (LTU) in NYC on 4/13/59 by telephone from the office of I. IRVING DAVIDSON, WDC, and, he believed, the call was charged to DAVIDSON's office telephone. He said DAVIDSON talked with DON LUIS first and informant was rather certain that there was a third person on the telephone in NYC at that time interpreting for DON LUIS since DAVIDSON speaks very little Spanish.

Informant said from what he has learned to date there is no Cuban community in WDC that is known to DEL PINO and he has met no one in WDC except DAVIDSON who appears to be particularly sympathetic with DEL PINO. He said he would attempt to identify any pro-Castro or Anti-Castro elements in WDC.

Informant said he would also attempt to ascertain how DAVIDSON became acquainted with DEL PINO and more about DON LUIS and additional info about contemplated activities in the U. S. during CASTRO's visit here. He said he would probably be returning to Miami when CASTRO leaves WDC but DEL PINO will probably follow CASTRO until CASTRO leaves the U.S.
