who identified himself as JIMMIE TRAINOR, 1339 North  
Mohawk, Chicago, Illinois, a resident at the above address,  
a settlement house managed by KARL MEYER. The pretext  
was conducted under the guise of a writer preparing an  
article on pacifist activity by individuals from the  
Chicago area.

This LHM is classified Confidential because data  
reported by CG 6264-S could reasonably result in the  
identification of a confidential informant of continuing  
value and compromise his future effectiveness thereof.
