NOTE: If contact missed send by urgent teletype. Subject is brother of Pedro Luis Diaz Lanz, the former head of the Cuban air force. He was assisted in his escape from Cuba by CIA, which agency is keeping his movements confidential as it is attempting to arrange the escape of subject's wife and children from Cuba. CIA, Washington, has indicated subject will be available for FBI interview in Miami, Florida. Subject's brother was ~~secretly~~ interviewed by Bureau and information obtained disseminated to interested agencies. The brother also testified before the Senate Internal Security Subcommittee concerning his knowledge of conditions in Cuba. Immediate interview of subject requested in view of tense situation in Cuba, and ~~subject~~ also held high position in Cuban air force.

MARCOS JOSE DIAZ LANZ, IS-CUBA. JULY 29, INSTANT, CIA, MIAMI, CONFIDENTICALLY INFORMED CIA HAD EFFECTED ESCAPE OF SUBJECT, FORMER INSPECTOR GENERAL, CUBAN REVOLUTIONARY AF, FROM CUBA. SUBJECT, BROTHER OF PEDRO LUIS DIAZ LANZ, FORMER HEAD CAF, WHO ALSO FLED TO US, ENTERED US ON JULY 27, LAST, BOTH PRESENTLY IN MIAMI. CIA INFORMS SUBJECT CONTACTED CONFIDENTIAL BASIS BY US INS, MIAMI. CIA EXPECTS TO EFFECT ESCAPE SUBJECT'S WIFE AND FAMILY BUT ADVISED FAMILY WILL NOT COME TO US. CIA REPRESENTATIVE STATES SUBJECT HAS BEEN IN HIDING IN CUBA AND HE DOES NOT FEEL SUBJECT WOULD HAVE ANY KNOWLEDGE RE IMMINENCY INVASION PLANS OF EITHER CUBA OR DOMINICAN REPUBLIC. CIA REQUESTS, FOR SECURITY REASONS, AND IF NO REASON FOR URGENCY, THAT FBI INTERVIEW OF SUBJECT BE DELAYED. CIA, MIAMI, WILL ADVISE WHEN SUBJECT'S FAMILY HAS REACHED SAFETY, AND UACB, MIAMI WILL CONDUCT INTERVIEW THEREAFTER. (S) (u)
