AND THEN ROB HIM OF THE ARMS. MORINO DID NOT KEEP APPOINTMENT.

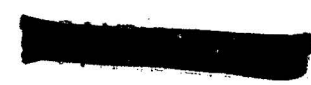

INFORMANT SAY LOCKLEY IS A MINUTEMAN IN ILLINOIS, AND IS A RADICAL WHO THINKS THE POLICE AND U.S. ARMY ARE AGAINST THE AMERICAN PEOPLE AND HAVE SOLD OUT TO THE COMMUNIST. LOCKLEY SAYS HE WILL BRING ALONG A MACHINE GUN AND IF THEY ENCOUNTER POLICE HE WILL OPEN UP. (X)(u)

U.S. CUSTOMS HAS BEEN NOTIFIED.

INFORMANT THINKS HE WILL HAVE MORINO-S ADDRESS LATER TONIGHT. LOCKLEY STAYS IN A MOTEL IN MIAMI, IS VERY SECURITY CONSCIOUS AND TELLS NOBODY HIS ADDRESS. (X)(u)
