WILLIAM WAYNE DALZELL, New Orleans Police Department No. 100181, was arrested by the New Orleans Police Department May 21, 1960 for cashing fraudulent checks.

PCI BETTY PARENT advised on June 3, 1960, that WILLIAM WAYNE DALZELL was identical with BILL WAYNE DAZELL, whom she had reported to the New Orleans Office.

WILLIAM WAYNE DALZELL was interviewed at the Orleans Parish Prison, New Orleans, where he is being held on a check charge in the city of New Orleans, and the theft of a amethyst stone in New York City. He furnished information which is being included in the attached letterhead memorandum.
