One copy of the enclosed letterhead memorandum is also being furnished to the New York Office for information in view of the statements attributed to WILLIAM DALZELL by PCI BETTY PARENT to the effect that DALZELL claims to be in contact with a man named RAYMOND in the Rockefeller Center, New York City. (X)

The enclosed letterhead memorandum is being classified "SECRET" as unauthorized disclosure of data contained therein could result in serious damages to the U. S., such as jeopardy of international relations and endanger the effectiveness of a program of vital importance to the national defense. (X)(u)

No dissemination is to be made of the enclosed material except to CIA at Bureau level. (u)

Confidential Informant NO T-1 is PCI BETTY PARENT. (X)

Interviews of SERGIO ARCACHA SMITH and GUY BANISTER were conducted by SA ERNEST C. WALL, JR. and SA WARREN C. deBRUEYS. (u)

SERGIO ARCACHA SMITH, head of subject organization in the New Orleans area, furnished information in addition to that which is attributed to him in the enclosed letterhead memorandum, concerning a few members of subject organization in the New Orleans about whom he has some suspicion regarding the sincerity of their stated political beliefs. This data is being made part of various individual subject files of the New Orleans Office in connection with investigation of various individuals in the "105" category. (u)

UACB, New Orleans will interview WILLIAM WAYNE DALZELL concerning the allegations attributed to him by BETTY PARENT, namely that DALZELL states he is going to Cuba as a news reporter, that he is working for a man in CIA named LARRY RAY, and also that he is in contact with a man named RAYMOND in the Rockefeller Center, New York City.
