On 6/16 & 7/30/71, SA ALFRED E. SEDDON contacted JOSE GARCIA SIERRA and SAUL MALDONADO, 361 Fuertes, Santurce, Puerto Rico. Both GARCIA and MALDONADO advised SA SEDDON that they resided at the above address, but do not know anyone by the name of the above-captioned individual.

On 6/7/71, U. S. Immigration and Naturalization Service (INS), Hato Rey, Puerto Rico, advised they had no locator card for the subject.

On 8/31/71, a source (See Nonsymbol Source Administrative Page) advised SA SEDDON the following information received from their informant, which they described as reliable:

Between 8/2/71 and 8/12/71, the subject was in Puerto Rico. He was in the possession of a large quantity of money, and made contact with University of Puerto Rico (UPR) and Inter-American University (IAU) students. While subject was in Puerto Rico, he stayed at the Hotel Bolivar, Room #9. While at the hotel, the subject received many telephone calls which asked for the occupant of Room 9, and not for the subject by name. The owner of the hotel keeps
