On 6/16 & 7/30/71, SA ALFRED E. SEDDON contacted JOSE GARCIA SIERRA and SAUL MALDONADO, 361 Fuertes, Santurce, Puerto Rico. Both GARCIA and MALDONADO advised SA SEDDON that they resided at the above address, but do not know anyone by the name of the above=captioned individual.
