There are transmitted herewith 12 copies of a letterhead memorandum dated 12-19-62 and captioned as above. The source of information is JOSE M. ACABEZON, head of the Madrid office of the Cuban Revolutionary Council - CRC, who furnished the information based on an interview of GARCIA on 11-29-62 by DOMINGO DEL VAL D'ANGELO. The letterhead memorandum is classified confidential to protect the source, who furnishes information on a continuing basis having to do with the national defense. (X) Spain Cuba

Extra copies of the letterhead memorandum are being furnished for the information of the New York and Miami Offices. No dissemination is being made locally inasmuch as it is known that the local station of CIA is in possession of the same information. (S)(u)

A separate letterhead memorandum is being prepared, suitable for dissemination, containing background information on LAUDELINO GARCIA VILLARES. (X)(u)
