On 1/29/64, IC NORMAN A. NOLAN reviewed the Army Officer Service record pertaining to EMIL GEORGE GARRETT as maintained by the Army Officer Personnel Section, Department of the Army, The Pentagon.

This file reveals that GARRETT was born on 9/23/18 at Denver, Colorado, and has Army officer file number 01103646. He served in the U. S. Army as an enlisted man from 1/12/42 to 9/15/42 and on 9/16/42 he was commissioned a Second Lieutenant, Army of the United States.

On 12/21/45 GARRETT was placed on medical retirement but was recalled to active duty on 7/10/47. He was placed on inactive duty on 4/30/48 but was again recalled to active duty on 10/21/50 and has been continuously on active duty from that time to the present.

The file reveals that GARRETT is currently a Lieutenant Colonel assigned to Ft. Leslie J. McNair, Washington, D. C. GARRETT was granted "Top Secret" security clearance in September, 1960, by the Assistant Chief of Staff for Intelligence (G-2), Fifth Army.

On the basis of GARRETT's Army Officer Service record it does not appear that any investigation be instituted concerning him.

However, Bureau permission is requested for WFO to interview GARRETT concerning his knowledge of FRANK ANTHONY STURGIS.

The current issue of the Montgomery County, Maryland, City Directory lists a GEORGE L. KILGORE, wife MARIAN, a mechanic for Loving Chevrolet Company as residing at 4419 Faroe Court. ROCKVILLE, MV.

Just above this name there is also listed one GEORGE A. KILGORE, wife ELIZABETH W., whose occupation is shown as Administrative Assistant, Department of Defense, and whose home address is listed as 3704 Spring
