source who is very close to FIORINI has been unable to furnish current information regarding FIORINI or the IACB because FIORINI is presently out of town. This source did advise, however, that if FIORINI and/or any followers of his have gone to Mexico, they may be at the Buchanan Ranch in Cozumel.

Configuratian

According to the Mexican Tourist Office, Miami, contacted telephonically on 10/2/68, Cozumel is in Quintana Roo Territory, Mexico.

It is believed that the above U. S. Customs source is WILLIAM JOHNSON, a former adventurer, who is very close to FIORINI. JOHNSON was formerly contacted by the Miami Office until his direction was turned over to U. S. Customs, Miami.

CAUKAS also indicated that U. S. Customs, Miami, was not conducting active investigation in this matter aside from contacts of the above source.

On 10/2/68, a no-name inquiry was made for FIORINI at his employment, G. M. Used Cars, 2480 Northwest 36th Street. According to an employee there, FIORINI departed about ten days previously to visit his ill mother in Norfolk, Va. He was to be gone approximately one week but has not been heard from since his departure.

On 10/2/68, MM 1312-C advised that he has been unable to learn anything further regarding the plans of captioned organization since FIORINI has not yet returned from West Virginia, where he is reportedly visiting relatives. Prior to his departure for "West Virginia", FIORINI indicated to this source that he would contact him promptly upon returning to Miami regarding possible service of the source with the captioned organization.
