CUBAN POLITICAL ACTIVITIES DASH IS DASH CUBA. ANTI-CASTRO MOVEMENT IS DASH CUBA. MM SIX THREE FIVE DASH S, WHO DEPARTED MM ABOUT THREE WEEKS AGO FOR HAVANA UPON INVITATION MAJOR PEDRO LUIS DIAZ LANZ, CHIEF OF CUBAN AIR FORCE, RETURNED MM YESTERDAY IN COMPANY PEDRO DIAZ AND HIS BROTHER, MARCOS DIAZ LANZ, CUBAN AF INSPECTOR. INFORMANT STATED HE IS NOW SECOND LIEUTENANT IN CUBAN AF AND ASSISTANT TO MARCOS DIAZ. INFORMANT REPORTED AS FOLLOWS. PEDRO DIAZ IS CONSIDERED SUSPECT BY FIDEL AND RAUL CASTRO AND ERNESTO GUEVARA BECAUSE OF HIS ANTI COMMUNIST BELIEFS. PEDRO BELIEVES THEY ARE WAITING OPPORTUNITY TO FALSELY ACCUSE HIM OF BEING TRAITOR IF PEDRO MAKES A BAD MOVE. PEDRO PLANS TO RENT OR BUY HOUSE IN MM IN CASE HE IS FORCED FLEE CUBA AND IS KEEPING PLANE READY FOR THIS EMERGENCY. PEDRO FEARS RAUL CASTRO IS ATTEMPTING PENETRATE AND TAKE OVER CUBAN AF.

PLANS REPORT FICTITIOUS INFORMATION TO CASTRO CONCERNING TRUJILLO OF DOMINICAN REPUBLIC IN ORDER DIVERT CASTRO-S ATTENTION. INFORMANT STATED AMERICAN CITIZEN FRANK FIORINI, NOW CAPTAIN IN CUBAN AF, IS IN CONFIDENCE OF PEDRO DIAZ AND WENT TO FBI HEADQUARTERS, WASHINGTON, WEEK AGO FOR SUPPORT FOR DIAZ. FBI UNABLE GIVE SUPPORT SO FIORINI) WILL NOW SEEK SUPPORT FROM STATE DEPT. INFORMANT STATED CONDITIONS VERY BAD UNDER CASTRO, WHOSE GOVERNMENT RAPIDLY COMING UNDER COMPLETE COMMUNIST CONTROL AND DOMINATION DUE TO ACTS AND INFLUENCE OF RAUL CASTRO AND ERNESTO GUEVARA. PLANS PEDRO DIAZ KNOWN ONLY TO PEDRO AND MARCOS DIAZ, FIORINI AND INFORMANT. INFORMANT EXPECTS MAKE FREQUENT TRIPS MIAMI AND WILL CONTINUE REPORTING. MM SUBMITTING ADDITIONAL DETAILS IN FORM SUITABLE DISSEMINATION. X(u)
