ReBulet to Havana 4/7/59 copies of which were furnished your office. Enclosed is a copy of Havana letter 5/15/59. This communication indicates that Fiorini has not been in Havana for approximately one month.

Reference is made to your airtel 5/21/59 captioned "Robert Arthur Williams, PSI." Information is contained in this airtel indicating that Fiorini is working for Cuban Air Force in the Miami area. You should promptly advise the Bureau of any pertinent information concerning the activities of Fiorini in the Miami area and furnish your recommendations as to whether an approach to Fiorini in the Miami area is feasible.

NOTE: Subject is American citizen and captain in Cuban Rebel Army. He was interviewed by the Bureau 3/31/59. Subject stated he was in U.S. on a confidential mission at request of Cuban Air Force who was concerned with growing threat of communists in Cuban Government. He furnished information concerning leaders alleged to be communists or communist sympathizers. He also furnished information concerning plans for potential revolutions in Caribbean countries. He offered his services as an agent for the U.S. Government in the fight against infiltration
