Re Boston letter to the Bureau, 7/11/72.

For information of Butte, BS 1891-PSI had advised on 12/21/72 that CAROLYN MUGAR would arrive in Boston on 12/23/72 to spend the holidays with her parents in Belmont, Mass.

On 1/9/73, source advised that CAROLYN MUGAR had entered Massachusetts General Hospital (MGH) the first week of January for a general check-up as she had not been feeling well. Source subsequently advised that CAROLYN MUGAR would remain in MGH for a period of time as it was discovered that she had a massive infection of her lower abdomen.

On 3/6/73, a knowledgeable source advised that CAROLYN MUGAR was confined at MGH from 12/29/72 to 2/14/73. She resides with her parents at 184 Clifton Street, Belmont, Mass. Source advised that CAROLYN will reside at that address during her period of recovery.
