Re Newark airtel to Bureau, 5/8/64.

By letter dated 8/3/64, the Newark Division furnished information received from NK 1913-S that subject is scheduled to speak in Newark, New Jersey, on 8/23/64. This information was received by informant at SWP meeting held 7/19/64, at which MURRAY ZUCKOFF, SWP member, commented that LANE has real proof that LEE HARVEY OSWALD did not kill President JOHN F. KENNEDY and that he, LANE, had interviewed a female witness who saw OSWALD at that time of the assassination but who was never questioned by the FBI.
