The identities of SAs who have observed the subject and his wife on the various dates listed in the details of this report are located in NY file 105-37544-Sub A. The identities of the SAs who observed activities of HIRSCH with IKARI are contained in NY 105-17706-Sub A and B.

The Legat, Tokyo, Japan, be letter dated 7/22/60, advised that the Amita Company, 631 Shime Goreimae-Cho, Kawahara-Machi, Maruda-Machi-Tori, Chukyo-Ku, Kyoto City, who were in contact with the subject, manufacture and sell gold, silver, and ivory trinkets such as silver hair ornaments and earrings; 70% of their products are exported to the United States. The Amita Company and its officials, and employees have had no trouble with the local police.

The Seattle office, by letter dated 8/5/60, advised that a check of the Credit Bureau of Tacoma, Washington, reflected a file for Captain JAMES W. YEMPEY and his wife, WILMA, beginning in May of 1958, and contained no unfavorable information. Further, a check of OSI, Mc Chord AFB, Washington, WASH reflects that Captain JAMES W. EMPEY saw service during WW II and began his present tour of active duty, 10/19/52.

It further reflects he was assigned to the ETO and was stationed in France in March of 1955. There he was joined by his dependents in 1956. His 201 file reflects that his wife is WILMA MARGARITA EMPEY, but the date of their marriage is not shown. Captain EMPEY claimed a child dependent, GARY EMPEY, born 10/23/43, place of birth not showm.
