Reference Bureau airtel to New York, dated 12/12/63,
and report of SA JOHN EDWARD HEGARTY, dated 1/2/64, at New
York.

Referenced Bureau airtel indicated that the NYCPD
reportedly had furnished the United States Secret Service
with a compilation of information in its possession concern-
ing FPCC leaders and activities in the New York area. Refer-
enced airtel requested that the New York Office arrange to
obtain a copy of the report and review same for any pertinent
information not already in the possession of the New York
Office.

Lieutenant BERNARD MULLIGAN, Bureau of Special
Services (BSS), NYCPD, advised SA AUGUST J. MICEK that no
formal report was furnished by the BSS to the United States
Secret Service.

Subsequently, Detective FRANK BIANCO, BSS, NYCPD, advised SA JOHN EDWARD HEGARTY that after the assassination of President JOHN F. KENNEDY, agents from the Secret Service came to the BSS and were furnished information from the files of the BSS concerning the original sponsors of the FPCC. Detective BIANCO stated that in view of the close liaison that exists between the BSS and the New York Office of the FBI, all of the information given to the Secret Service has previously been furnished to the New York Office of the FBI. Detective BIANCO made available, in addition to the above mentioned information concerning the original sponsors of the FPCC, the file maintained by the BSS on the FPCC. This file was reviewed by SA HEGARTY, and there is no pertinent information contained therein not already in the possession of the New York Office.

Concerning the New York Chapter of the FPCC, it is to be noted that NY 3467-S and NY 3367-S, who were members of the Executive Committee of the New York Chapter of the FPCC, have advised that in conversations with VINCENT T. LEE, the National Office Director of the FPCC, LEE has advised that the FPCC has been dissolved. The above mentioned informants have indicated that there has not been a meeting of the Executive Committee of the FPCC since early in November, 1963.

In view of the above information, this case is being placed in a "Pending Inactive" status. At the end of six months, if there has been no further activity on the part of the New York Chapter of the FPCC, a report will be submitted and this case will be placed in a "Closed" status.
