Permission granted for your office to effect anonymous telephone calls mentioned in referenced letter provided full security of your source of information can be assured. Recontact Anchia and contact NY 3042-S to determine degree of publicity given to date to Trujillo's dereliction in handling of July 26th Movement funds. If publicity of a degree indicating common knowledge among members of July 26th Movement, Bureau interposes no objection to course of action outlined in referenced letter. (S)(u)

Disruption of relations within July 26th Movement in New York should not be considered as ultimate objective of your counterintelligence program. To extend your program, anonymous telephone calls of the nature described in referenced letter should also be made to appropriate Cuban officials of the Cuban Delegation to the United Nations. You should also prepare an anonymous letter containing details of Trujillo's denunciation and indications of distrust of entire leadership of July 26th Movement in New York City. This anonymous letter should be sent to Heriberto Gonzalez Fonseca who is well known to you as the individual responsible for direction of the July 26th Movement in the United States. Gonzalez's address in Cuba has been reported as being c/o Movimiento Revolucionario, 26 De Julio, Arroyo 27, Habana, Cuba. Subsequent to preparation of this letter in the Spanish language and prior to forwarding it to Gonzalez, it should be furnished to the Bureau in its proposed finished form for review and appropriate approval. (S)(u)

To fully realize all advantages of your plan, bear in mind necessity of having appropriate live informants in a position to volunteer to assume duties of any officials ousted from the Movement as a result of adverse publicity or disciplinary action originating within the Movement from Havana. (S)(u)
