Examination of the above accounts by SA ANDREW J. SHANNON for the month of July, 1960, failed to disclose that funds were furnished to subject committee or known sponsors of the committee as set forth on pages six and seven of referenced report of SA CONWAY (S) (U)

On 7/15/60, WF 1161-S (protect identity and characterize as having furnished reliable information in the past) advised SA DONALD HOETING that he has no knowledge of subject committee (S) (U)

On 7/27/60, CSWF 1035-S (protect identity and characterize as having furnished reliable information in the past) advised SA HOETING that he has no knowledge of the subject committee.

Referenced New York airtel to Bureau disclosed the New York Office was discontinuing the monitoring of all bank accounts except the accounts of subject TABER and the FPCC. In view of this, WFO will consider instant case RUC.

The WFO, however, in the monthly monitoring of the Cuban bank accounts set forth in instant airtel and in contacts with informants [WF 1196-S\*], [WF 1133-S\*], and [WF 1134-S\*], (S) will be alert to any information regarding the FPCC and known sponsors of this committee (S)

WFO will submit in form suitable for dissemination any pertinent information received in instant case.
