Attached hereto is information pertaining to the membership of captioned individual in the Minutemen organization. This information reflects that the last known address of subject was within the Los Angeles field division.

On 8/19/68, IA 4730-S made available a portion of the MM membership files which were formerly in the possession of TROY HOUGHTON, San Diego, California, the former West Coast Regional Coordinator of the MM, who mysteriously disappeared in May, 1967. Due to HOUGHTON's disappearance, the files reflect no activity after February, 1967. HOUGHTON's MM # is 930 and much of the correspondance is either to or from this number.

The files, which were available to this office only briefly, have since been returned to their original location. The attached information is not necessarily all the information concerning subject's activity but rather that which showed subject's background and last known address. Source has advised that the files contain the names of many inactive members and drop-outs but due to the poor condition of the files, unless otherwise noted, it was impossible to tell if subject had become inactive or if the lack of recorded activity was due to HOUGHTON's disappearance.

In those instances where there is a notation "Transferred from Norborne" this indicates that the subject either changed his residence from some other regional area to the Western area or submitted his original ANY 0/11208 application to the MM Headquarters in Norborne, M ssouri.
