Dr. ERNESTO ARAGON y GODOY, 233 East 69th Street,  
NYC, who is secretary to Dr. JOSE MIRO CARDONA, President  
of the Consejo Revolucionario de Cuba (CRC), furnished  
detailed information relative to his recent trips to WDC  
and details of his and MIRO CARDONA's conferences with  
U.S. Government officials. The interview of ARAGON was  
conducted on 5/10/62, and he furnished the following  
chronology:

While in WDC with MIRO CARDONA, at the Hanger-  
Annapolis Hotel, they received a notification from the  
office of Attorney General ROBERT F. KENNEDY desiring  
that Dr. MIRO CARDONA see the Attorney General (AG) on  
4/4/62 in the AG's office. ARAGON stated that they were  
informed the appointment with the AG for MIRO CARDONA  
was arranged by a mutual friend of the Consejo and of  
the AG. MIRO CARDONA was most receptive of this invita-  
tion, and stated that he would be there on 4/4/62.
