Dr. ERNESTO ARAGON Y GODOY, 233 East 69th Street, New York City, on 3/6/63 furnished a complete list of Cubans now serving in the United States Army and stationed in Fort Jackson, South Carolina. Dr. Aragon advised that he would also keep the New York Office advised and furnished up-to-date lists of the names of Cubans serving with the Cuban Unit in the United States Army at Fort Jackson, South Carolina. (S)(u)

There is enclosed for the Bureau, Miami and Savannah, one copy each of the list furnished by Dr. Aragon for information purposes. (S)(u)

For the information of Savannah, Dr. Aragon is the Delegate of the Consejo Revolucionario de Cuba (CRC) which is headed by Dr. JOSE MIRO CARDONA. Dr. ARAGON spends most of his time in Washington, D.C. where he acts as the representative of Dr. MIRO CARDONA with the United States Department of State, the Pentagon, and with Attorney General ROBERT F. KENNEDY. (S)(u)

In the event any information furnished by Dr. ARAGON is utilized by Savannah, the identity of Dr. ARAGON should be protected by his request and he should be described as having furnished reliable information in the past. (S)(u)
