Information furnished by MM T-6, anonymous source, included in this report, was originally transmitted to the New York Office April 2, 1966. Information pertaining to organizations and individuals referred to in the material furnished by MM T-6 has been appropriately disseminated to the respective files.

MM T-3 also advised EDEN had been trying to get in contact with ~~ROLANDO MASFERRER~~, who reportedly was training Haitians in the Everglades in Florida. He related EDEN claimed to have served in the U. S. Army Medical Corps. He described EDEN as a "pro-rightist" whose ideas and ideals followed very closely to those of the John Birch Society. MM T-3 advised EDEN was arrested around September, 1965, for robbery in the Miami area. He also has reportedly been apprehended with arms by U. S. Customs.

Records of the FBI, Number 492 725 6, reflect RALPH GRANT EDEN, born December 15, 1939, Nitro, West Virginia, was arrested for burglary and Grand Larceny, September 24, 1965, Dade County, Florida.

On March 13, 1966, MM T-4, an individual personally acquainted with the subject, advised she had been in Miami around 1961 and in contact with GERALD PATRICK HEMMING. At that time she was single and had a boy friend named HAROLD MARTINEZ. She had previously been in Cuba seeking support to overthrow the SOMOZA Brothers, the leaders in Nicaragua. Also around that time she was involved with one NORMAN (LNU), whose brother was an editor for the "Daily Worker." According to MM T-4, both NORMAN and subject appeared to be pro-Communist. Further, at that time she expressed a dislike for the counter-revolutionary movement in Miami.

The "Worker" is an East Coast Communist publication and was formerly known as the "Daily Worker."

It has been previously reported information was received the subject had been the girl friend of one HAROLD MARTINEZ, described as a Nicaraguan Communist residing in Tegucigalpa, Honduras, and had a child by him.

In 1960 the subject admitted to Special Agents of the FBI she went to Cuba as a tourist from December 23, 1959, to January 3, 1960, and her expenses to and from Cuba were paid by the Cuban Federation of University Students.
