Re Bureau letter to Miami with copies to Tampa,
dated 6/11/64, under the above caption.

Referenced letter referred to report of SA JOHN
H. MILLER, dated 5/22/64, at Tampa, concerning ROBERT RUTGER
BRAUER, IS - CUBA, wherein on Page 7 it is indicated that
TP 139-S advised on 4/27/64 that during the course of a
picnic on the previous day at Tampa BRAUER made the state-
ment that he had received a letter from a Colonel MOODY in
Miami, and MOODY allegedly was involved in an invasion of
Cuba with an army of refugees in May or June (presumably
1964..).

Miami indices were found to be negative on any
Colonel MOODY identifiable with Cuban affairs at Miami.
Further, his name had not come to the attention of Agents
working Cuban matters in the Miami Office.

Inquiries made of MM 492-S, MM 635-S, MM 639-S,
MM 873-S, and PSIs JOSE T. MEDINA and ARTURO GONZALEZ
GONZALEZ resulted negatively in learning the identity of
Colonel MOODY.

On July 16, 1964, GERALD PATRICK ~~HEMMING~~, 1036
Southwest 5th Street, Miami, Florida, a U. S. citizen who
has been involved in Cuban revolutionary activities since
1959, stated that he had no personal knowledge of a Colonel
MOODY, but perhaps MOODY is identical with a Colonel
REYNOLDS MOODY who frequently writes letters to the Editor
of "The Miami Herald," at Miami, Florida. HEMMING stated
that he had no knowledge of MOODY's being involved in
Cuban exile activity at Miami.
