ON AUGUST SIX, SIXTYTHREE, MM SIX THREE NINE DASH S,  
WHO HAS FURNISHED RELIABLE INFORMATION IN THE PAST, ADVISED  
AS FOLLOWS WITH REFERENCE TO THIS INCIDENT (X)(u)

OSCAR PINO, A CUBAN EXILE, HAS A SMALL ANTI CASTRO  
ORGANIZATION AND EIGHT CUBANS IN A TRAINING CAMP AT NO  
NAME KEY, FLORIDA. ONE OF PINO-S MEN CALLED THE OWNER OF SOME OF  
THE LAND AT NO NAME KEY AND OFFERED TO PAINT HIS HOUSE  
THERE IN EXCHANGE FOR FURTHER PERMISSION TO USE THE LAND. (X)(u)

GERALD PATRICK HEMMING, AN AMERICAN ADVENTURER, WHO  
PREVIOUSLY OPERATED THE CAMP AT NO NAME KEY, FOUND OUT ABOUT THIS,  
AND BECAME JEALOUS, THINKING THAT PINO MIGHT HEREAFTER BE  
CONSIDERED AS THE CAMP OPERATOR BY ANTI CASTRO ASSOCIATES INSTEAD

OF HIM (X)(u)  
ON AUGUST THREE, SIXTYTHREE, WHEN PINO WAS IN MIAMI. (X)(u)

HEMMING THREATENED TO CALL TOGETHER HIS MEN AND <sup>forcefully</sup> ~~FORCEFULLY~~ PUT PINO-S MEN OFF NO NAME KEY. PINO INVITED HIM TO TRY IT. HEMMING HAD NO ACTUAL INTENTION OF ATTEMPTING THIS AND DOES NOT PLAN TO DO SO IN THE FUTURE (X)(u)

PINO THEN RETURNED TO NO NAME KEY. EN ROUTE HE WAS STOPPED AND SEARCHED FOUR TIMES BY LOCAL AND STATE POLICE WHO HAD BEEN ALERTED RE THIS MATTER (X)

[MM SIX THREE NINE DASH S] <sup>(X)(u)</sup> EXPECTS NO FURTHER TROUBLE BUT WILL FOLLOW THIS SITUATION CLOSELY. THE BUREAU WILL BE KEPT ADVISED. NO DISSEMINATION MEMO BEING PREPARED. END AND ACK PLS
