also advised these reports had reached CIA headquarters in Washington and that after careful study, he had recommended that CIA have nothing further to do with CAPO and that he appeared to be uncontrollable and desirous of broadening his activities into other fields outside of radio communications. (S)(u)

DU BOIS said, however, that CIA was going to continue to "monitor" CAPO's activities and he felt that at some future date if CAPO appears to be more favorably inclined to be controlled, CIA might use him in some future operation. (S)(u)

On June 26, 1961, Mr. DU BOIS informed he had learned through DENNIS WATKINS that CAPO had moved his vessel from Sugarloaf Key and that it is now located on the Miami River. (S)(u)

Miami is maintaining close contact with CIA concerning their possible operational interest in CAPO at some future date. The Bureau will be kept advised. (S)(u)
