REMM TELS TO BUREAU AND SAN JUAN NOVEMBER 15, 1965.  
 ON NIGHT NOVEMBER 15, 1965, MRS. LOURDES BLANCO DE  
 CUESTA, WIFE OF ANTONIO CUESTA, LATTER MILITARY CHIEF OF  
 COMANDOS L, ADVISED AT MIAMI, FLORIDA THAT SHE HAS NOT SEEN  
 HER HUSBAND SINCE SOMETIME LAST WEEK AT MIAMI. SHE CLAIMED  
 NOT TO KNOW HIS PRESENT WHEREABOUTS. SHE DECLINED TO ANSWER  
 QUESTIONS CONCERNING POSSIBLE PARTICIPATION OF ANTONIO CUESTA  
 ON THE NOVEMBER 14, 1965 ATTACK ON HAVANA. SHE COUNTERED  
 BY ASKING THAT THE CUBAN EXILES BE ALLOWED TO HANDLE THE PROBLEM  
 OF CUBAN COMMUNISTS WITHOUT U.S. INTERFERENCE.

ON NOVEMBER 16, 1965, CARLOS ZARRAGA MARTINEZ, KEY SOURCE  
 CUBA (PROTECT) ADVISED HE HAD LEARNED THAT AN IMPORTANT  
 OFFICIAL OF RECE HAD STATED THE FOLLOWING INDIVIDUALS HAD  
 FORMED A GROUP WHICH HAD CARRIED OUT SOME PHASES OF THE ATTACK  
 ON HAVANA ON NOVEMBER 14, 1965: JESUS FERNANDEZ, ORLANDO  
 RODRIGUEZ, WHO MAY BE IDENTICAL WITH ORLANDO ARRAZOLA ROD-  
 RIGUEZ, MIGUEL IZA, AND ROBERTO AGUILAR.

FOR INFO SAN JUAN, LUIS MORENO, THIRTIETH OF NOVEMBER  
 MOVEMENT, WAS CONTACTED NOVEMBER 16, 1965 AND PROVIDED ADDRESS  
 OF JESUS FERNANDEZ, MILITARY COORDINATOR OF THIRTIETH OF  
 NOVEMBER MOVEMENT AS CALLE 22, 3817, SANTA ROSA, BAYAMON,  
 PUERTO RICO.
